Athletes partaking in the Cannondale Team Program have an expectation of a weekly social media post showing rider on or with their Cannondale bikes in a race, group or social situation with a @ridecannondale, @thecrankandsprocketbicycleco, #RideCannondale and #thecrankandsprocket handle so we can repost as appropriate.
4. All Podium Images will be shared with a @ridecannondale, @thecrankandsprocketbicycleco, #RideCannondale and #thecrankandsprocket handle so we can repost as appropriate.
5. The Crank & Sprocket Bicycle Co. and Cannondale have permission to include your photo, video, recorded audio or comments in any promotional material used for marketing without liability or compensation.
6. Rider shall wear a helmet at all times while riding ANY bicycle.

11. Rider shall inspect equipment daily for damage and wear.
